Short Profile of Prof. Qiao Liu: Dr Qiao Liu obtained his DPhil in law from the University of Oxford. He is currently an Associate Professor in the TC Beirne School of Law, University of Queensland (Australia). Prior to joining the School in 2007, Qiao was a Lecturer at the University of the West of England (Bristol) since 2005. He has also taught part-timely at the University of Leicester and the Shanghai Institute of Foreign Trade. He was a visiting scholar at the Harvard Law School from July to August 2012 and is an Adjunct Professor of Comparative Law at the School of Law of Xi'an Jiaotong University (China).

Qiao teaches and researches in contract, commercial law and Chinese law, with a particular interest in comparative study of Chinese and Anglo-Australian private law. He has published in the Modern Law Review, the Cambridge Law Journal, the Sydney Law Review, Legal Studies, Lloyd's Maritime and Commercial Law Quarterly and University of New South Wales Law Journal (all A* journals according to the 2010 ARC ranking table). His book entitled Anticipatory Breach (Hart Publishing Oxford 2011) has been favourably reviewed by a leading scholar as being 'persuasive... to contemporary courts, and especially to the UK Supreme Court' and '[tending] to bring English law into harmony with other European systems'. Dr Liu's Chinese translation of Peter Birks' seminal book Unjust Enrichment (2nd edn OUP 2005) was recently published by the Tsinghua University Press in China (2012). He also serves as the Managing Deputy Editor-in-Chief of the Chinese Journal of Comparative Law (OUP) and holds membership or executive roles in a number of academic societies in the UK, China and Europe as well as in Australia. He was elected a member of the International Academy of Comparative Law early 2013. He is currently a member of a small expert group working with the United Nations Commission on International Trade Law (UNCITRAL) Secretariat on the updating of the Digest on the Convention on Contracts for the International Sale of Goods. Dr Liu has obtained several major research funds in China including the Chinese State Social Science Fund and the Fund for New Century Excellent Talents and has been an awardee of the UQ ECR Grant. In 2014 Dr Liu has been awarded a UQ Foundation Research Excellence Award and a highly prestigious ARC Discovery Early Career Researcher Award to further his Comparative Studies of Australian and Chinese Private Law.

Description of the Cruise:

Departing Folly Bridge in Oxford city centre, the cruise travel through a fa**scinating stretch of River as the** cruise **travels** down the university regatta course towards quaint Iffley village. **Cruise will** pass ancient Folly Bridge, Christchurch College and Meadows and the university rowing houses. This is one of the busiest and most colourful stretches of the Thames (the stretch locally known as The Isis). Rowing eights, punts, university boats and large pleasure cruisers come together in a lively display of all that the river has to offer.

How to reach at Oxford River Cruise: Please take off at Speedwell Street Bus Stop just outside the police station and walk down toward The Folly, Folly Bridge (Please refer map at page 12). You can use your Oxford City Sightseeing buses to reach here.

Oxford City Sightseeing: Your Ticket for Oxford City Sightseeing (Open top Bus) is valid for 24 hrs on both Guide Friday GREEN and City Sightseeing RED buses and you can get on and off at any of the 19 stops on the tour – keep a hold of your ticket for re-boarding!

<u>Note</u> : Day ONE Welcome Dinner*, Day TWO Social Networking Dinner* and Day THREE* social networking events are only for those delegates who have registered and paid for the social events.

Important Information

Presentation Duration: You are required to give an oral presentation of 15 minutes (maximum) plus 5 minutes for discussion where other participants may ask you questions regarding your presentation and research. Please note that your presentation must be in English language.

Ways of Presentation: For your presentation, you can either use PowerPoint or Prezi, whichever is more convenient for you. For PowerPoint presentation, we request you to kindly bring it on your own USB/memory stick. You do not need to email us your presentation copies. However, please note that each delegate will be given internet access during the conference.

Wifi: Each Delegate will be given a wifi code to use internet connection during the conference

Conference Venue: Please note that the venue of the conference is Seminar Room 8 (Syndicate Room), University of Oxford, St Anne's College, 56 Woodstock Rd, Oxford OX2 6HS, United Kingdom. Getting to Conference Venue: Please note that there are no parking facilities available onsite. Kindly therefore make your own arrangements for parking your vehicle. We further regret that parking in Oxford can be difficult and expensive; therefore, we recommend using the park-and-ride.

Park-and-ride: There are park-and-rides available on the outskirts of Oxford, so you are sure to find one no matter from which direction you have come. They are all clearly sign-posted, are linked to the centre of the city by regular bus services, and are open 24 hours per day (bus services run until about 11pm). From Peartree and Watereaton you can catch buses which stop very close to St Anne's.

By car: Limited street parking is available in Wellington Square and St Giles. It is metered from 8am to 10pm with a 2-hour maximum stay each and every day including Sundays; after 10pm overnight stay is permitted. There are also severe restrictions on access to many of the streets in the centre of the City. Traditional routes such as High Street/St Aldates/Queen St and Cornmarket are either closed to vehicles or have very limited access and are protected by number plate-reading cameras and frequent police patrols. You have been warned! The nearest public car parks are at Worcester Street, Gloucester Green, the Westgate Centre and at the Railway Station. They are all expensive and should you wish to try North Oxford as an alternative, many areas now have residents' only parking.

By train: Oxford railway station is located on the western edge of the city centre, about 20 minutes' walk from St Anne's. There are also two direct buses operated by Stagecoach which run fairly frequently from the station to the College (Buses 14 and S3). The station is managed by Thames Trains, with routes from Stratford-upon-Avon to London Paddington and Bristol, and is also served by Virgin Trains from Scotland to the south coast. Services to London Paddington run twice an hour during the day, with journeys taking around 60 minutes. Information on rail journeys and fares to/from Oxford are available from National Rail Enquiries. Tel: 08457 484950.

By bus: The main bus station in Oxford is located at Gloucester Green in the City Centre, approximately 15 minutes' walk from St Anne's. National Express buses run to and from Oxford to locations throughout the UK. The Oxford Tube runs from London (Victoria, Marble Arch, Notting Hill Gate and Shepherd's Bush) to Oxford every 10-15 minutes including throughout the night. The X90 also runs from London (Victoria, Marble Arch and Baker St) to Oxford up to every 15 minutes. The airline buses run regularly from London Gatwick and London Heathrow to Oxford.

University Museum of Natural History - If dinosaurs and geology is your thing, then the University Museum of Natural History is definitely worth a visit. The Grade I listed building is renowned for its Oxfordshire dinosaurs, the dodo and the swifts in the tower – you'll have to go and explore to see exactly what we're talking about. 
